

**SUMMER SCHOOL: INTRODUCTION TO TOTAL DIET STUDIES FOR ASSESSING EXPOSURE**  
**INTERNAL APPLICATION: SUNDAY 22<sup>ND</sup> – FRIDAY 27<sup>TH</sup> JUNE 2014, TUBITAK, TURKEY**

- ⇒ **Anyone wishing to attend the Summer School must complete an application form**
- ⇒ **Download the form and save to your computer**

Applicant should have at least a Bachelor of Science at Honours level (BSc Hons.) or equivalent in food science or another science subject (e.g. dietetics, biology or chemistry or completed the non-clinical teaching for undergraduate medicine). Those with degrees in other science or engineering topics will be accepted provided they have A-level(s) or equivalent (Advanced Higher or International Baccalaureate) in biology, biochemistry or human biology.

**Modules will be taught in English.** To benefit from the learning, candidates should be conversant in English and able to understand the lectures, take part in discussions and follow supplementary information.

Applications must be received on or before the deadline. Applicants must be self-financing and from

- EU28, Candidate Country (Former Yugoslav Republic of Macedonia [MK], Iceland [IS], Montenegro [ME], Serbia [RS] and Turkey [TR]) **OR**
- International cooperation partner countries, which are classified as low-, lower-middle- or upper-middle-income countries not including those associated with FP7 or entities established in Hong Kong, Macao or Taiwan

### *About you*

In addition to your family and first name, please add any 'preferred name' in parenthesis (e.g. JONES, Frederick [Fred]) to ensure your name badge is correct.

We need to collect some demographic data for reporting, specifically age and sex. If you prefer not to use your actual date of birth, please use 1<sup>st</sup> January and the correct year (e.g. 01/01/1976).

Nationality refers to the country issuing the passport you intended to travel on.

Telephone numbers should include the international dialling code, e.g. UK +44 XXXX XXXXXX

### *About your organisation*

Applicant's supervisor/ line manager must sign the form to confirm the organisation has approved attendance regardless of whether you or the organisation is paying the associated costs.

### *Travel to TUBITAK and accommodation*

Delegates are expected to attend the whole Summer School. However, you may arrive on Sunday, 22<sup>nd</sup> June or early Monday, 23<sup>rd</sup> June 2014. There is an informal get-together on Sunday evening for those present, and registration is from 09.00 until 10.30 on Monday, 23<sup>rd</sup> June 2014.

Number of nights refers to accommodation. Hotel bookings will be discussed on an individual basis and will require a credit card number or similar to guarantee booking.

### *Total Diet Study*

Priority will be given to those new to an established total diet study or countries currently without TDS Programme. However, all applications will be considered and those seeking to undertake continuing professional development are encouraged to apply on this basis.

### *Why do you want to attend this summer school?*

Any applications without this justification will be rejected automatically.

The justification should explain why you want to attend the Summer School (e.g. new to TDS in your country), how this knowledge will be applied.

⇒ The justification should be 400-600 words (ca. 5000 characters with spaces)
